If spontaneous vomiting occurs, have victim lean forward with head down to avoid breathing of vomitus, rinse mouth and administer more water. OBTAIN MEDICAL ADVICE. Do not induce vomiting or give anything by mouth to an unconscious person.

**Eye Contact:** Flush eyes with running water for 20 minutes. Hold eyelids open during flushing. If irritation persists seek Medical Attention.
